STALLION SERVICE CONTRACT

This agreement, entered into this ____ day of _____ (month), _____ (year), by and between Lopin Slow Partnership, hereinafter referred to as Stallion Owner, and _____, hereinafter referred to as Mare Owner.

- A. Whereas, Lopin Slow Partnership is the owner of the stallion "Lopin Slow", and the Mare Owner is the owner or lessee of the mare

_____, registration number _____ by _____ and out of _____.

- B. Whereas the named stallion will stand at stud during the _____ (year) breeding season at Meyer Training Center, and the parties hereto desire to contract for the servicing of the named mare by the named stallion during said season.

Responsibilities of Mare Owner:

- A. Pay a breeding fee in the amount of \$ 1250 payable as follows:
1. Booking fee of \$250, hereby receipted for, which is nonrefundable and is part of the above breeding fee.
 2. The balance of the breeding fee, \$ 1000.
- B. The mare is halter broke, healthy, and in sound breeding condition.
- C. Allow Meyer Training Center to have a qualified veterinarian check the mare for normal breeding conditions, and to perform other veterinary services that the veterinarian staff deem necessary for the proper treatment and protection of the mare and/or foal at side.
- D. Pay when billed all veterinary expenses incurred in the breeding of the mare, care of the mare and her foal including but not limited to, palpations, ultrasound, and farrier work.
- E. Pay shipping and mare care fees as described below.

Notes:

- A. There will be no charge for first shipment of cooled semen. After first shipment normal charges will apply.
- B. Shipped semen will require \$250 collection fee. If sent via airport, counter-to counter, the shipping fees will be \$125 within the U.S.
- C. Refundable container deposit of \$300 will be refunded to the Mare Owner upon receipt of returned Equitainer by Meyer Training Center.
- D. Shipped semen will not be released by Meyer Training Center until all amounts due for breeding have been paid in full including refundable container deposit and shipping charges.
- E. Shipment is only guaranteed if we are notified by 12 Noon, CST.
- F. Semen will only be shipped Mondays, Wednesdays and Fridays.
- G. Mare care is \$8 per day pasture, \$12 per day stall.
- H. Mare will not be released until Mare Owner pays breeding fees, mare/foal care, and vet bills.

Responsibilities Stallion Owner:

- A. Reserve for the Mare Owner one booking to the stallion, Lopin Slow, for the _____ (year) breeding season.
- B. Guarantee to the Mare Owner a return breeding to the named stallion the following breeding season for the named mare upon receipt of written statement from a qualified veterinarian that a live foal did not result from this breeding. A live foal is defined as one that stands and nurses without assistance.

Both parties further agree to the following:

- A. Lopin Slow Partnership, Meyer Training Center, and the Stallion Owner are not liable for any sickness, disease, or injury which may be suffered by the mare and/or foal at her side.
- B. This agreement shall not be assigned or transferred by either party without the express consent of the other party.
- C. The following conditions and concessions are involved in arriving at the above listed breeding fee:
